A. PRESIDENT'S REPORT: Ben - Ben lost his voice, so Carmen will be leading this PAF meeting! Family Giving closed officially. Hit or exceeded goal which is great. Nica has left so reminder: always be recruiting more PAF participants. Bond Measure $C$ and $G$ both passed, so Ben involved with school district to see funds through.
B. PRINCIPAL'S REPORT: Evelyn - In reviewing school's receiving bond measures in SRCS, SRFACS was second to last, so timing of approval is great. Coffee with PAF this morning went well. Gratitude for PAF for Charter School Development Conference support - was great to be there since getting less district support and laws getting tighter so critical to know how to proactively plan/fund for charter schools. Good networking opportunities too. Enrichment Fall session was rewarding, nice to see children share what they had learned. Thanks too to PAF support for tutoring. Enrollment is coming back up, lottery application Jan9-Jan20 (for March 8 pull) and hoping to get back to pre-pandemic levels - important to
educate that SRFACS is a public school, since many think its private. Reminder: still lots sick out there, remind children to keep hands out of mouths and wash hands!
C. TREASURER'S REPORT: Sean - Balance Sheet pretty consistent, Profit \& Loss just shy of 94 k from Family Giving, a lot of spend forthcoming as we prepare for Carnaval, already received more than thought for Teacher Wish Campaign so that's great. Will get posted on site.

i. Grant Opportunities: Nora/Carmen - Could still use more help with Grant opps. Have an applicant for STEAM lab pending. Carmen found The Face Foundation, will forward info about President Macron visiting US last week; visited New Orleans public charter school and he mentioned funding for French Public schools - could be good to look into. They look at grants in April.
ii. Teacher Wish Campaign: Erica/Nora - Teacher Wish Campaign going well. Had request for different types of balls for recreation. At $75 \%$ of ask thus far and good participation across classrooms. Need to include $8^{\text {th }}$ grade ask? Discussion: microscopes to share, but need other science equipment, so will add ask for that.
